THE INLAND POST AMENDMENT (No. 20) WARRANT, 1920, DATED MAY 27, 1920, INCREASING THE RATES OF POSTAGE ON LETTERS AND PARCELS.

1920. No. 805.

We, the Commissioners of His Majesty's Treasury, in exercise of all powers given to us by the Post Office Acts. 1908 to 1918.(a) and of all other powers enabling us in this behalf, do, by this Warrant, made on the representation of His Majesty's Postmaster-General (testified by his signing the same) and under the hands

of two of us, the said Commissioners, order, direct and declare as follows:-

1. This Warrant shall be read as one with the Inland Post Warrant to Warrant, 1903,(a) and all Warrants amending the same.

be read with existing Warranta.

2. On and from the date upon which this Warrant comes into Repeal. operation Regulations 2 and 4 of the Inland Post Amendment (No. 17) Warrant, 1918,(b) shall be repealed.

3. There shall be charged and paid on letters the following Rates of rates of postage (that is to say):—

postage on letters.

- On every letter not exceeding three ounces in weight, two-
- On every letter exceeding three ounces, for the first three ounces, twopence, and for every additional ounce, or fractional part of an ounce, one halfpenny.
- 4. There shall be charged and paid on parcels the following Rates of rates of postage (that is to say):

postage on parcels.

- On every parcel not exceeding two pounds in weight, nine-
- On every parcel exceeding two pounds and not exceeding five pounds, one shilling.
- On every parcel exceeding five pounds and not exceeding eight pounds, one shilling and threepence.
- On every parcel exceeding eight pounds and not exceeding eleven pounds, one shilling and sixpence.
- 5. This Warrant may be cited as the "Inland Post Amendment Short title (No. 20) Warrant, 1920."
- 6. This Warrant shall come into operation on the 1st day of Commence-June, 1920.
