THE FOREIGN AND COLONIAL PARCEL POST AMENDMENT (No. 56)
WARRANT, 1913. DATED MAY 26, 1913.

1913. No. 577.

We, the Commissioners of His Majesty's Treasury, in exercise of all powers given to us by the Post Office Act, 1908,* and of all other powers enabling us in this behalf, do, by this Warrant, made on the representation of His Majesty's Postmaster-General (testified by his signing the same) and under the hands of two of us, the said Commissioners, order, direct, and declare as follows:—

1. This Warrant may be cited as "The Foreign and Colonial Parcel Post Amendment (No. 56) Warrant, 1913."

2. This Warrant shall be read as one with the Foreign and Colonial Parcel Post Warrant, 1906,† and all Warrants amending the same.

Short title. 3. The Foreign and Colonial Parcel Post Amendment (No. 51) Warrant, 1912,‡ is hereby repealed.

Warrant to be read with existing Warrants. Repeal. 4. On every outgoing parcel addressed to Chili and transmitted *via* Buenos Ayres and the Andes, there shall be charged and paid the rates of postage specified in Part I. of the Schedule hereto.

Rates on parcels to Chili. 5. In lieu of the rates of postage now payable on outgoing parcels addressed to Bolivia, there shall be charged and paid the rates of postage specified in Part II. of the Schedule hereto.

Rates on parcels to Bolivia. 6. Except by permission of the Postmaster-General, there shall not be forwarded, conveyed or delivered by post under this Warrant any parcel the weight or dimensions of which shall exceed the weight and dimensions specified in the Schedule hereto.

Maximum weight and dimensions. 7. This Warrant shall come into operation on the 2nd day of June, 1913.
